Aim and Objectives

Overall aim is to establish an action learning, transnational peer review exchange programme between partners which will focus on three interrelated sub-themes



Aims and Objectives (cont.)

Three sub-themes

- 1. The education, training and business sectors need to co-operate in developing new ways of identifying and catering for the varied needs of young people as individuals. Therefore, the exchange will focus on initiatives that are being taken to develop more flexible approaches and greater diversity in pathways, breaking down the historical demarcation between work, training and education.
- 2. Relatedly, as stated above, there has been considerable investment at member State level in trying to encourage low achievers to complete secondary school in order to improve their employment prospects. This, however, needs to be balanced against the need to consider 'positive' leavers and 'negative' leavers in different ways. It is increasingly clear that a broader view of learning is required. This exchange will also focus on exchange of experience in relation to seeking to develop/mainstream a broader view of learning.
- 3. Finally, there have been innovatory approaches which incorporate the active involvement of young people who have had direct experience of the reality that "early school leavers "face. As such these initiatives are seeking to change service delivery by drawing on the social and human capital that is availably locally. This exchange would also focus on this aspect.



Aims and Objectives (cont.)

Objectives:

- to develop an Online Good Practice Exchange, which would brings together access to resources, case studies connections with practitioners and policy officers for developing services for the target group.
- to undertake a mapping exercise at a local level in order to identify the needs of the target groups and also the gaps in local provision.
- to develop and undertake 4 trans-national Peer Review And Development Workshops.

- The production of three peer review exchange reports

- Seven local mapping reports and linked action plans
- An Online Good Practice Exchange And Development Forum, which would bring together access to resources, case studies connections with practitioners and policy officers
- An annual dissemination and mainstreaming workshop in each partner location
