# EU and Participatory Democracy – utopian myth or new reality?

On the eve of the European Parliament elections, the issue of the possible failure of European democracy haunts the media and public opinion. Most Europeans are evidently discontent with, or simply disengaged from, the European Union. There seems to be a perception that the European decision-making process is in a certain way the exclusive domain of an undemocratic elite, which operates without consulting the population.



Despite the fact that the European Parliament's ability to represent Europe's citizens has improved significantly over the years, voter turnout in European elections 2004 has followed the downward trend experienced since 1979. In 2004 this represented a participation figure of 45.5% for the EU as a whole, with a participation of 47.1% in the EU-15 and 26.4% in the new Member States.

Nowadays, participation is considered as the heart of democracy. For a democracy to live, people need to be involved in the life of their society and in the decision-making networks. Hence the growing interest in the idea of Participatory Democracy. Today this term is used for the active part played by the people in the working of democracy; the willing contribution of citizens and organisations to the political and social life of their society. It enriches representative democracy by creating "horizontal" links in society, as opposed to the hierarchical or "vertical" links of representative democracy

Participatory democracy strives to broaden the range of people who have the opportunity to make meaningful contributions to decisionmaking. Technological development, especially that which enables community narratives and the acquisition of knowledge, may prove an important force in achieving this empowerment.

German Socialist Matthias Groote, representing the EP at the conference for <u>eParticipation Day</u> said that "the European institutions are accused of being very far from their citizens. This feeling

can be avoided by electronic participation via the internet" And indeed, new interactive media can provide powerful tools for strengthening government-citizen relations.

Today if we – citizens - really want to participate in the management and development of our European society, we need

a real legal power to influence things and denounce incompetence, abuse, theft and bribery.



Participatory Democracy backed up

by new media might be a revolutionary tool to efficiently install such a mechanism. But, as each revolutionary tool, it might be easily hijacked for less noble aims. Therefore, when promoting and implementing the interactive relations between governments and citizens, we must not forget that our democracy remains the representative one and its principles are TRANSPARENCY AND ACCOUNTABILITY.

Qec-ERAN is very keen on promoting active participation and it is in that spirit that we have developed the project on LOCAL FORUMS FOR DEVELOPING PARTICIPATORY DEMOCRACY. The project is co-funded by the EU Fundamental Rights and Citizenship Programme, which has as its overall aim the development of innovative approaches to participatory democracy at local and regional level.

# *Qec ERAN workshop: "Monitoring the Urban Dimension in EU Cohesion Policy: EU 12″*

The latest Qec-ERAN workshop took place in Prague, Czech Republic, on 18-19 March 2009. The event forms part of a series of conferences on the theme of "the urban dimension in EU cohesion policy" in different member states. The objective of these events is to feed the outcomes into the EU mid-term review of the new EU Cohesion Policy programming arrangements that will take place in 2009 and 2010.





Conference delegates, Prague, 18-19 March 2009

Co-inciding with the Czech EU Presidency, the Prague workshop aimed to highlight how the EU 12 member states have addressed the "urban dimension" in their NSRFs and Operational Programmes. The conference was organised with the active involvement of DG Regio as well as the EP Intergroup on Urban Policy and Housing who are both very interested in the current programming period and have already launched a discussion about the future programming period.

The conference brought together over 60 participants working in urban development/regeneration. Speakers included representatives from DG Regional Policy, the European Parliament, the European Investment Bank, Managing Authorities for Structural Funds from Czech Republic, Slovenia, Slovakia, Hungary, Romania, and Poland, and city representatives from Poznan (Poland), Prague (Czech Republic), Gyor (Hungary) , Lubljana (Slovenia) and Timisoara Timisoara).

Previous events include "<u>Monitoring the urban</u> dimension in cohesion policy: Spanish and <u>Portuguese perspectives</u>" (2-3 April 2008, Madrid, Spain) and "<u>Monitoring the urban</u> dimension in cohesion policy: Dutch and <u>Belgium perspectives</u>" (19 September 2007, Antwerp, Belgium).

Twenty Years of European Urban Policy: AGM and Study Tour

This year QeC-ERAN is celebrating its 20<sup>th</sup> anniversary. The organization came into existence with the support of the former DGXXVI, now DG Regional Policy, in order to help develop and implement some of the first Urban Pilot Projects. The network was instrumental in securina the URBAN programme, which, together with the territorial exchange programmes such as INTERREG and URBACT, is a key 'red thread' connecting its members.

The year 2009 also marks 20 years for the Brussels Regional Capital. Urban development in Brussels has 'shadowed' the evolution of EU Policy. A series of EU co-financed interventions have taken place alongside broader urban and community development programmes.

Qec ERAN will host a unique two and half day event on 24-26 of June 2009 to review 20 years of EU urban policy using Brussels as a "living laboratory" for undertaking the review. The event is designed to be a stock take of where we are and what is to come. We are organizing the event in such a way that Brussels becomes a living laboratory for the review. The event has the following elements:

- Four Urban tours/peer reviews. These are only open to 40 delegates. - An evening of debates, music and food. This is again open to 120 delegates. this will take place on the evening of 25 June.



### Local Forums For Developing Participatory Democracy

Local Forums for Developing Participatory Democracy project has entered its implementation phase after the first Steering Group Meeting took place in Brussels in January.

The general objective of the project - promoting Participatory Democracy - is currently being developed in the framework of the European elections 2009. Since January all the partners have been working on local strategies to increase the participation of young adults and other EU citizens in the European Parliament elections. On the 21st and 22nd of April we will hold in Brussels the First Transnational Workshop on "Promoting Youth and EU migrant participation in the EU Parliament elections". The overall aim of this workshop will be to provide partners with thematic and strategic expertise in order to improve their local strategies, but it will also allow them to exchange their local experiences and practices. The workshop will bring together а number of people from different organisations, like the European Parliament, European Youth Forum, Action Aid UK, and projects like "THINK ABOUT IT".

# G20 pledges action on tax havens, but few signs of real reform

The G20 Summit approached economic crisis from all fronts: financial market regulation, economic stimulus, job security. Leaders agreed to use €5bn in unspent EU funds to upgrade energy and internet connections. And they raised the ceiling on EU aid to countries having difficulties. The credit line - which covers countries not using the euro - was lifted to €50bn. Leaders also pledged €75bn in additional support to the International Monetary Fund to help countries in trouble. Wrapping up a two-day summit, the leaders issued a joint statement saying the bloc had made "good progress" in implementing the €200bn stimulus adopted in December. Leaders package expressed confidence the measures - which include tax cuts and bank bailouts - would revive the economy but said it would take time. Read more.

Meeting with social partners on economic crisis and May Summit

The President of the European Commission, José Manuel Barroso, and the Prime Minister of the Czech Republic, Mirek Topolánek – representing the Council Presidency - met the European social partners to discuss the social impact of the crisis, and how to prepare the May summit. The Tripartite Social Summit showed a clear consensus on the urgent need for coordinated action at European level to complement and support actions at Member State level, together with a rejection of protectionist measures. The Commission and the social partners agreed on the need to modernise the European model, in order to preserve its values and to maintain the level of social cohesion, prosperity, environmental protection and the quality of life in Europe. Agreement was also reached on launching a consultation process to prepare the May Summit. It will include holding three seminars, with the participation of social partners and the relevant national authorities, between now and May in the Czech Republic, Sweden and Spain focusing on three key issues, respectively mobility, access to employment and skills. # Active Inclusion, renewed social agenda and cross-border health services on the EP Agenda

31 March was a busy day for European Parliament Committees with two reports and a draft directive. The Employment and Social Affairs Committee adopted an own-initiative report on Active Inclusion (draft 21/1/2009).

On 30th March 2009, the European Parliament Committee on Industry, Research and Energy adopted the report on the Internal Market in Electricity, tabled in second reading by Rapporteur Eluned Morgan (PES). Recognizing energy poverty as a "growing problem in the Community", the text calls on Member States to develop national action plans or other appropriate frameworks to tackle energy poverty", "ensure the necessary supply for vulnerable customers", develop integrated approaches (in particular through social policy and energy efficiency measure). It also encourages Member States to define vulnerable customers and prohibit disconnection in this

context, in critical times. The text now has to be adopted by the European Parliament in plenary on 21st April. More information on the overall procedure can be found <u>here</u>.

# Strengthening structural funds' support to energy efficiency: Parliament supports Commission proposals

On 2nd April, the European Parliament supported a proposal by the European Commission to enlarge support to energy efficiency measures in all EU Member States. The rule changes would mean European Regional Development Fund (ERDF) money could co-fund national, regional or local authority schemes to install e.g. double glazing, wall insulation or solar panels in housing, or to replace old boilers with more energy efficiency ones, in all Member States. The ERDF currently funds such schemes only in the new (EU-12) Member States, and only in common parts of a building (or the entire building, if it's social housing), in deprived urban areas. While the proposal was first intended to apply only to "low-income households", it has been amended to highlight a broader purpose of "social cohesion". Yet EAPN believes the overall change can contribute to the fight against energy if it is followed by concrete poverty,



implementation and keeps a strong focus on low income households. More information can be found <u>here</u>.

# 2009 EU peer review programme on social inclusion

The European Commission has launched its 2009 peer review programme on social inclusion. This year, the programme will look at 10 policies/practices related to social inclusion. Among these, there will be a peer review examining the Vienna homelessness monitoring system: "Counting the homeless – improving the basis for planning assistance". This peer review will take place on 12-13 November in Vienna and will involve the following peer countries: Denmark, Germany, Hungary, Italy, Luxembourg, Norway, Slovenia, and Sweden. # 8th Meeting of People experiencing poverty on the EC's website

The 8th Meeting of people experiencing poverty will take place in Brussels on 15 and 16 May 2009 and will address the topics of Housing, Financial Inclusion and Access to Basic Services. The basic purpose of this event is to listen to people experiencing poverty, and to establish a dialogue with policy- and decisionmakers in the field of fight against poverty and social exclusion at the European level and at national levels. It is organised jointly by the Czech Presidency of the European Union, the European Commission and the European Anti-Poverty Network. Read <u>more</u>.

# The European Parliament urges the European Commission to regulate microcredit in Europe

In a new report adopted on March 24th 2009, the European Parliament urges the European Commission to regulate micro-credit in Europe. The document suggests: the creation of a central agency coordinating all micro-credit operations and initiatives in Europe, more EU financing for such initiatives, the promotion and dissemination of good practices within the sector of micro-credit and the elaboration of a new definition of micro-credit. It also points out that public's awareness should be raised on the issue. Read <u>more</u>.



#### Social Platform response to the European Commission consultation on health inequalities

Social Platform welcomes the decision of the European Commission to consult civil society at EU level on its future actions to reduce health inequalities and focuses on five key messages concerning: social exclusion, gender and equality principles, the Open Method of of Coordination, participation people experiencing poverty, mainstreaming social and public health goals in all policies. #### European Women's Lobby: The EU antidiscrimination directive: let's stay mobilized!

On 16 March, the European Parliament's Civil liberties Committee adopted Ms Buitenweg's report on the proposal for a new antidiscrimination directive presented by the European Commission. The project constitutes a step forward in the fight against all forms of discrimination, The European Women's Lobby welcomes the inclusion of multiplediscrimination in the draft report, which recognises the existence of situations where people are discriminated on several grounds. Yet, several issues remain problematic. Read more.

#### ILGA-Europe launches "Be **Bothered**" campaign on the EP elections 2009

On 25 March, ILGA launched a campaign on the EP elections with the motto "Be Bothered. Vote for а human rights friendly European Parliament". The purpose of this campaign is to make sure the Parliament remains committed to human rights and equality generally and the rights of LGBT people in particular and also to energise **ILGA-Europe** membership, organisations and individuals across the European Union, to take active part in this year's elections. # COFACE has issued a memorandum for the **European Elections**

COFACE (the Confederation of Family Organisations in the European Union) reminds that families are being hard hit by the crisis through rising unemployment, falling purchasing power, increasing debt, poverty and social exclusion. It is also seeing growing uncertainty and concern for the future among broad swathes of the population, leading many

# EU looks ahead to future gender equality challenges

European Commissioners were joined by other EU institutions and representatives of civil society at a special meeting on 10th March to discuss the future of gender equality policy in Europe.

The Commissioners Group on Fundamental Anti-discrimination Rights, and Egual **Opportunities** met in the context of International Women's Day. The extraordinary session took stock of progress under the 2006–2010 Roadmap on gender existing equality and discussed future challenges for EU gender equality policy. Read more.

On 11 March 12, 2009, the European Parliament adopted the report by Magda Kósáne Kovács (PES, HU) on "*the social situation of the Roma and improving their access to the labour market in the EU*". Calling for an overall strategy to integrate the Roma community into the European Union, the owninitiative report states: "*Educating young people should be a priority in combating poverty and social exclusion of the Roma*". ### External evaluation of the 2007 European Year of Equal Opportunities for All (EYEO)

The overall aim of this evaluation was to determine whether the EYEO was a success both at the European level and at the level of the 30 Participant Countries. As part of the final evaluation report, four thematic reports were produced, three of which to focus on three grounds of discrimination, namely racial and ethnic origin, age and sexual orientation. The fourth report addresses the way in which gender was mainstreamed across the actions and activities. carried out respectively at national and EU level.
